Greetings Brother Knights



I joined Freemasonry in Alberta in 1963 and will therefore be eligible for my Fifty Year Jewel in 2013. It has been a very active and fulfilling journey through the various ranks of many levels of Freemasonry to date, with no end in sight.

I am an R.C.M.P. veteran, a retired Director of Transportation Services for Strathcona County, where I make my home in Sherwood Park, and currently own and operate an Alcohol & Drug Testing business. You are a volunteer in your Lodge, Chapter, Council or Preceptory until you are elected by the members as an officer. Now you have become the servant of the members and must strive to bring honour to your office and to yourself.

The RIBBON of the ORDER

QUESTION: In the ritual book, for the order consecration it mentions a ribbon to be displayed. Can you tell me about this ribbon and if there is one where can we obtain one?

ANSWER: Regulation **R6.6.1** states the **Jewel of a Presiding Preceptor** shall be the red patriarchal Cross, suspended from the ribbon of the Order, worn around the neck, red with white edges, 4.5 centimeters wide.

Researching the "Statutes" of Sovereign Great Priory, we find the 1885 Statutes contain the same wording in Statute 115. (the metric measure was not included.) The Sixth Annual Assembly of the National Great Priory of Canada, 1881, adopted this wording.

"These jewels to be suspended by the ribbon of the order: red with white edges 1¼ inches wide."

This wording has remained unchanged to this day. Of interest, we note, that when a survey of Preceptorries was conducted, last Spring, there were almost as many different ribbons being used today, as there are Preceptorries.

I was born and raised in Edmundston, New Brunswick. I am married to Suzanne Asselin and we have two children, and five grandchildren. I am also an Ordained Minister of the International Council of Community Churches (I.C.C.C.). I studied at the University of Moncton (B.A.), the University of Ottawa (M.A.) and the Pastoral Institute of the I.C.C.C. (L.Th., Dr.Chr.).

Professionally, I have served for 37 years in the Federal Public Service, which includes such positions as Program Manager for the Treasury Board Secretariat, Policy Advisor for the Privy Council Office, several years as Chief Advisor for the Ethics Counsellor's Office and as the first Director of the Senate Ethics Office, a new entity of the Canadian Parliament created in 2005. I retired in April 2011 from the Federal Public Service and since do occasional consultancy work in political ethics as Special Advisor for parliamentarians and Canadian Parliament institutions. I am also Associate Pastor of the Ottawa-Gatineau Community Church, Ottawa, ON. In respect to the above, I am Vice-President and member of the Board of Directors of the Canadian Chapter of the International Council of Community Churches Inc.; member of the Association of Professional Executives of the Public Service of Canada; and, member of the Ethics Practitioner's Association of Canada.

My Masonic career started in 1980 when I was initiated in Eddy Lodge # 41, GRQ, served as Worshipful Master (1993), was Deputy Grand Chaplain (2002) and District Deputy Grand Master (2007) of the Grand Lodge of Quebec. In capitulatory masonry, exalted in Coronation Chapter # 27, GRQ (1982) and served as First Principal (1992), was Grand Chaplain (1999 to 2003) and Grand Superintendent (2005) of the Grand Chapter of RAM of Quebec. My Knight Templar journey started when I was consecrated in Ottawa Preceptory # 32 in 1982, serving as its Presiding Preceptor (1998), was Grand Sword Bearer (2004), Provincial Grand Prior for the Kingston-Ottawa District # 4 (2008), Grand Chaplain (2010) and Grand Council Member (2011). In the Ancient and Accepted Scottish Rite, I was received and have been a 32nd degree member of the Valley of Ottawa since 1983. I am also a member and have served in several appendant Masonic organizations.
